\*For the purposes of this document, "Parent" signifies Parent, Guardian or Authorized Transportation Pickup (Information must be updated in FACTS SIS to reflect all Authorized Transportation Pickup Persons. Please access "Web Forms" through your Parents Web account to update any necessary information.)

### Lower Division (K-5)

#### Before School

**Please note: Please use the drop-off car lane next to the building. All students MUST enter at the breezeway/crosswalk area in the large parking lot.** Please do not use the shoulder of MacDill Avenue, the small parking lot in front of the Office, or the grass/Staff parking spaces near the entrance/exit of the parking lot for dropping off purposes. Please obey all posted directional signs for the **SAFETY OF ALL**.

#### **Classrooms open at 8:00am, Attendance taken at 8:15am**

- Lower Division students may be in the designated, supervised area starting at 7:45am (without charge).
- Lower Division students arriving before 7:45 am will be sent to Before School Care Program, time will be noted and FACTS account will be charged accordingly.
- Any Lower Division students who enter a "Before School Care" area (classroom or gym) prior to 7:45 am, time will be noted and FACTS account will be charged accordingly.

\*Before School Care Program begins at 7:00am on each scheduled school day, unless otherwise noted or communicated; Special C.A.R.E.S. programming will be advertised (additional charges may apply)

Before School Care (Daily): \$15.00/student

Before School Care (Monthly): \$75.00/student

#### After School

**Please note: All students MUST exit at the breezeway/crosswalk area in the large parking lot.** Please do not use the shoulder of MacDill Avenue, the small parking lot in front of the Office, or the grass/Staff parking spaces near the entrance/exit of the parking lot for picking up purposes. Please obey all posted directional signs for the **SAFETY OF ALL**.

#### **Dismissal at 2:45pm**

- Lower Division students may be picked up at dismissal time (if Parent is picking student up early, student must be signed out in the Office).
- Lower Division students will go to After School Care Program if not picked up at 3:00 pm. **Parent MUST sign out student from After School Care Program at the car drop-off lane. Parents must use the lane closest to the building. Please stay in your car, be ready with your I.D., and show your BCS Name Tag in the windshield. The After Care Sign-out Person will call for your child and help child to the car.**

-If a Lower Division student is not picked up by 3:00pm, student will go to aftercare. FACTS account will be charged accordingly (beginning at 3:01pm).

\*Bayshore Christian School provides space for vendor-sponsored activities (such as Soccer Shots®, Bricks4Kidz®, Clay Club, Music Lessons, Tutoring Sessions, etc.) that may have their own costs associated. Please note:

-If a vendor-sponsored activity *begins before 3:15 pm*, FACTS account will not be charged.

-If a vendor-sponsored activity *begins after 3:15 pm*, FACTS account will be charged accordingly.

-Parent must pick up student at scheduled ending time of vendor-sponsored activity or student will go to aftercare. **Parents coming at the end of vendor-sponsored activity must use the lane closest to the building. Please stay in your car, be ready with your I.D., and show your BCS Name Tag in the windshield. The After Care Sign-out Person will call for your child and help child to the car.**

-If Parent does not pick up student at scheduled ending time of vendor-sponsored activity, FACTS account will be charged accordingly.

\*\*Bayshore Christian School students may be included in school-sponsored activities, according to their age: Fall/Spring Musical (3:00-4:15pm). Please note:

-Parent MUST pick up student according to the afterschool care procedure at scheduled ending time of school-sponsored activity, or within 5-minute “grace period” (by 4:20pm)

-If Parent does not pick up student at scheduled ending time of school-sponsored activity, FACTS account will be charged accordingly (beginning at 4:21pm).

\*After School Care Program ends at 6:00pm (sharp) on each scheduled school day, unless otherwise noted or communicated; Special C.A.R.E.S. programming will be advertised (additional charges may apply)

After School Care (Daily): \$20.00/student

After School Care (Monthly): \$240.00/student

LATE Fee: \$15.00/quarter hour
