Legal Guardian Consent Form for F-1 Status International Students

In order to be considered for admission at Bayshore Christian School (BCS), the parent/guardian of an international applicant must either register their student through [American Homestay Network](#) or appoint a guardian who resides in the Tampa Bay Area and agrees to take all responsibility for the student during their study at our school. If appointing a guardian, the requirements of this individual include, but are not limited to, the following:

- ✓ Must be over 25 years old
- ✓ Must be a U.S. Citizen or legal resident alien, or possess an active U.S. visa
- ✓ Must be available by phone and email for immediate contact in case of an emergency or other school matters
- ✓ Must assist in providing information concerning the international student's timely travel to and from the campus during breaks
- ✓ Must provide and will be responsible for the applicant's personal wellbeing, legal matters, medical care, disciplinary issues, educational concerns, transportation, and all other matters related to the student during his or her time as an F-1 status student in the United States
- ✓ Must be available to BCS Administration and Teachers for conferences or other pertinent meetings concerning the student's education
- ✓ Must act as a liaison between the student, parent, and BCS in matters related to the student's study at our institution and stay in the U.S.

Please return the completed form, along with a copy of the Legal Guardian's U.S. photo I.D. or passport I.D. page, to the BCS Admissions Office by mail, fax, or email to complete your student's application file.

Only students who have completed this form or completed registration with American Homestay Network will be considered for admission.
